10-Year Health/Life Safety Survey Review

Superintendent Temple met with Scott Johnson of Richard L. Johnson and Associates, to review the survey. The items identified were door closers on doors at the elementary school and high school, there was some glass not fire rated, exit lights to be replaced, and storage of chemicals. There was nothing major to report on the survey.

School Report Card

Superintendent Temple, said School Report Cards are a required federal mandate for any state school that receives federal funding, and that annually the State of Illinois assigns summative designations to all schools K-12. This year we received the following designations: The Elementary and Middle Schools received a designation of Commendable, and the High School received the designation of Exemplary. We will work towards the designation of Exemplary for all schools next year. It is mandated for the School Report Card to be on our website.
